BORSA ITALIANA HAS APPROVED THE ADMISSION TO LISTING ON EURONEXT MILAN OF THE SHARES OF CIVITANAVI SYSTEMS S.P.A.

CIVITANAVI SYSTEMS S.P.A SETS PRICE RANGE AT EUR 4.00 TO EUR 5.20 PER SHARE

Pedaso (FM), 1st February 2022 - Civitanavi Systems S.p.A. ("Civitanavi" or the "Company"), one of the leading pure-play providers of inertial navigation and stabilization systems, announces that Borsa Italiana S.p.A. (the "Italian Stock Exchange"), with provision no. 8827/31.01.2022, has approved the admission to listing (the "Listing") of the ordinary shares of the Company (the "Shares") on Euronext Milan, a regulated market organized and managed by Borsa Italiana S.p.A. ("Euronext Milan").

The price range for the institutional offering (the "**Offering**") has been set at EUR 4.00 to EUR 5.20. The final offer price will be determined by way of a bookbuilding process. The indicative valuation range of the Company based on outstanding 25,000,000 shares before the Capital Increase (as defined below), is between approximately EUR 100 million and EUR 130 million. The launch of the Offering is subject to the approval of the prospectus by CONSOB.

The Offering is reserved to qualified investors in Italy, in the European Economic Area and in the United Kingdom and foreign institutional investors outside the United States of America pursuant to Regulation S of the United States Securities Act of 1933, (as subsequently amended), with the exclusion of institutional investors in Australia, Canada, Japan and the United States and any other foreign country in which the Offering is not possible without the authorization of the competent authorities. The Offering does not provide for any public offering in any jurisdiction.

Details of the Offering

It is envisaged that the **Offering** will consist of up to 9,700,000 Shares, resulting from: (i) up to 7,200,000 newly issued ordinary shares of the Company (the "**New Shares**") resulting from a capital increase with the exclusion of pre-emptive rights (the "**Capital**")





Increase") with a gross target proceeds of up to a maximum of approximately EUR 37.4 million, and (ii) up to 2,500,000 Shares offered for sale by the sole shareholder **Civitanavi Systems Ltd**. The lock-up period for both the Company and its sole shareholder Civitanavi Systems Ltd will be 12 months.

The Offering also includes the granting of a greenshoe option ("the "**Greenshoe**") by Civitanavi Systems Ltd in favour of Intermonte SIM as stabilization manager on behalf of the Joint Global Coordinators to purchase up to 1,455,000 shares, corresponding to 15% of the Shares placed under the Offer. This greenshoe option may be exercised, in whole or in part, within 30 days following the listing date.

Upon closing of the Offering, assuming the full exercise of the Greenshoe and placement of all offered Shares, the total number of Shares held by the market will be equal to 11,155,000 of the Issuer's share capital. Free float after the Offering will represent up to 34.6%, subject to the full exercise of the Greenshoe.

Offer period

The Offering is subject to approval of the prospectus by the CONSOB. Following the approval and publication of the prospectus, the Offering is expected to commence on 2nd February 2022 and to end on 14th February 2022, unless closed earlier. Trading in the Shares is expected to commence on or around 17th February 2022.

Use of Proceeds

The Company intends to use the net proceeds from the capital increase to i) increase production capacity (new production facilities, factory automation and continuous improvements in production processes) and expand its geographic presence (e.g., the United Kingdom and Spain); ii) support product development and innovation (to improve accuracy, size, weight, power and consumption) and accelerate the process of developing and commercializing next-generation integrated stabilization and navigation solutions; and iii) support the search for new talent and expand the business development and sales team.

In the context of the Offering, the Company has appointed **Berenberg** and **Intermonte** as *Joint Global Coordinators* and *Joint Bookrunners*. Intermonte is also acting as Sponsor for the purposes of the Listing. **Emintad Italy** supports the Company as Financial Advisor. The Legal Advisor appointed by the Company is **Grimaldi Studio Legale**, **BDO Tax**





S.r.l. Stp acts as Tax Advisor, while **Simmons & Simmons** is acting as Legal Advisor to the Joint Global Coordinators and Joint Bookrunners. **BDO Italia S.p.A.** is the Auditing Company appointed and subject to carry out the verifications of the Business Plan and the Management Control System.

Civitanavi Systems S.p.A. will adhere to the simplification regime provided for by Articles 70, paragraph 8 and 71, paragraph 1-bis, of the CONSOB Regulation on issuers no. 11971/1999, as subsequently amended, and will therefore avail itself of the right to derogate from the obligations to publish information documents provided for by Articles 70, paragraph 6 and 71, paragraph 1 of the aforementioned Regulation on the occasion of significant mergers, spin-offs, capital increases through the contribution of assets in kind, acquisitions and disposals.

Civintanavi Systems, born as a start-up in 2012, is one of the main players in the design, development and production of inertial navigation and stabilization systems used in the aerospace and defense sectors in space, terrestrial, aeronautical, naval and industrial, mining and oil & gas. The Company vertically provides high accuracy systems, designed and manufactured with methods, techniques and algorithms based on FOG (Fiber Optic Gyroscope) and MEMS (Micro Electro Mechanical Systems) technology, also integrated with devices for satellite navigation. Today it carries out its activities in Pedaso (FM) and in two other locations, in Ardea (RM) and in Casoria (NA), counting on a staff of 123 employees operating throughout Italy.
